Dear Mr. Johnson:

Pursuant to RCW 80.28.060 and WAC 480-80-101 and WAC 480-80-105(1)(c), please find enclosed for filing the following proposed revision to the WN U-60, Tariff for electric service of Puget Sound Energy ("PSE" or "the Company"):

Original Sheet No. 80-R.1 - Schedule 80 General Rules and Provisions (Continued)**

The purpose of this tariff revision is to allow PSE to suspend its collection of its reconnection charge until 180 days after the resumption date of disconnections allowed under Governor Jay Inslee's Proclamation 20-23.15, in compliance with Appendix A to Order No. 03 in Docket U-200281.

On April 17, 2020, Governor Inslee issued Proclamation 20-23.2, which prohibits all energy providers from 1) disconnecting residential service due to nonpayment; 2) refusing to reconnect residential customers who were disconnected due to nonpayment; and 3) charging late fees or reconnection fees. The prohibition was set to expire on May 4, 2020, but subsequent proclamations have extended that date through July 31, 2021.

The tariff sheets described herein reflect an issue date of June 9, 2021, and effective date of July 9, 2021. Posting of proposed tariff changes, as required by law and the Commission's rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-100-193.
