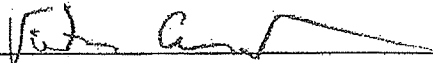

Engineered plans are required by the Washington State Department of Health and the Washington State Utilities and Transportation Commission for their approval prior to construction.

This Application grants no rights to Applicant and shall not be deemed approved by NWWWS unless and until (a) this Application is approved in writing by NWWWS, (b) Applicant and NWWWS mutually execute and deliver a written Water System Extension Agreement, and (c) all required governmental approvals of the extension and the Water System Extension Agreement, including without limitation all required approvals by the Washington State Department of Health and the Washington State Utilities and Transportation Commission, have been obtained and all appeals thereof have been resolved on terms satisfactory to NWWWS in its discretion.

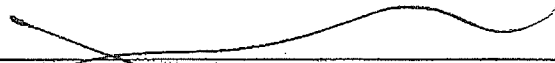

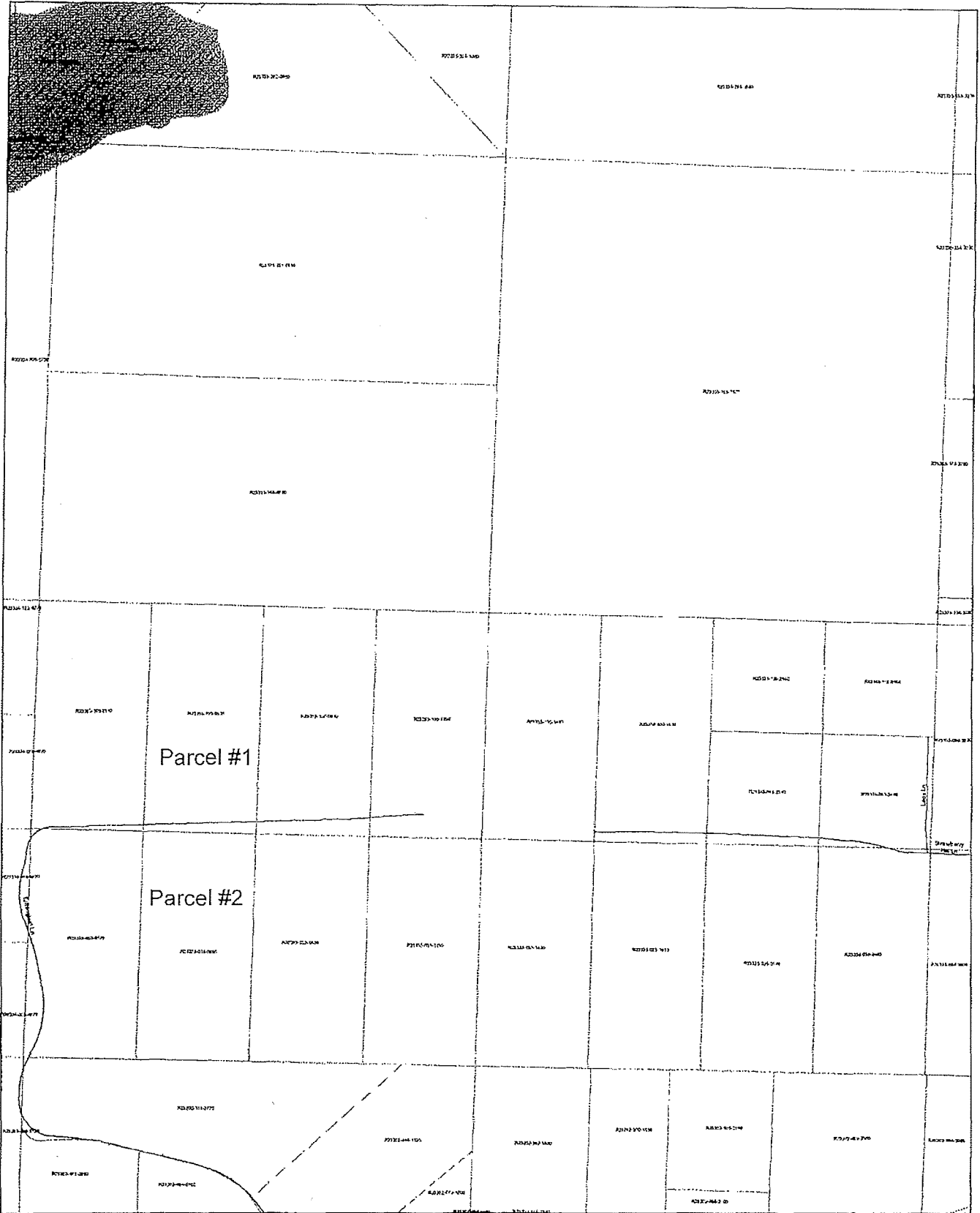
