Dear Mr. Johnson:

Puget Sound Energy (“PSE”) hereby submits proposed revisions to its natural gas Schedule 141X, Protected-Plus Excess Deferred Income Tax (“EDIT”) Reversals Rate Adjustment. This filing, pursuant to RCW 80.28.060 and Chapter 480-80 WAC, proposes revisions to the following natural gas tariff sheet.

WN U-2 - (Natural Gas Tariff):

Original Sheet No. 1141X-F – Protected-Plus Excess Deferred Income Tax (EDIT) Reversals Rate Adjustment

The purpose of this filing is to submit an annual filing no later than September 1st of each year as established in Order 10 (Order 8, p. 202, ¶763 as modified by Order 10, p. 7, ¶22) in Dockets UE-190529 and UG-190530 (consolidated). On August 10, 2021, the Commission filed a Notice of Intent to Amend Final Orders in newly consolidated Dockets UE-190529, UG-190530, UE-190274, UG-190275, UE-171225, UG-171226, UE-190991, UG-190992, UE-200843, and UG-200844, subsequent to the Internal Revenue Service Private Letter Ruling dated July 26, 2021, (“Modified Orders”). This filing adds language to the tariff schedule which clarifies that no change will be made to the tariffed rates under this schedule until the Commission provides direction for how these rates should change in conjunction with or subsequent to issuing its Modified Orders. As stated, this filing does not currently propose a change in the natural gas revenue requirement nor does it propose to change any Schedule 141X rates.
