The purpose of this filing is to update the budgets and termination dates in electric and natural gas Schedule 83 and 183, (Conservation Service for electric and natural gas programs, respectively).

PSE also revised electric and natural gas Schedule 201 (Low Income Weatherization) to include customer eligibility thresholds that align with the current U.S. Department of Energy – Washington State Low-Income Weatherization Assistance Plan Manual prepared by the Washington State Department of Commerce.

PSE also proposes to revise electric and natural gas Schedule 253 to change the title from Resource Conservation Management (Energy Performance Incentive Programs) to Energy Performance Incentive Program. PSE no longer offers a program under the Resource Conservation Management title and Energy Performance Incentive Program better reflects the breadth of measures and services offered under this schedule.

Electric Schedule 258 has also been modified to update the program and funding cycle dates. Additionally, language was added to include an option to run multiple customer submission periods during the competitive phase until funding is exhausted.

Consistent with WAC 480-109-110(1)(h) and Condition (3)(e), PSE reviewed the proposed Conservation tariff revisions with the CRAG on October 1, 2021. PSE has received no comments nor suggestions for revisions.

The tariff sheets described herein reflect an issue date of October 29, 2021, and effective date of January 1, 2022. Posting of proposed tariff changes, as required by law and the Commission's rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-100-193.
