## Re: Advice No. 2021-46 PSE Natural Gas Tariff Revision

Pursuant to RCW 80.28.060 and Chapter 480-80 WAC, please find enclosed for filing the following proposed revision to the WN U-2 Tariff for natural gas service of Puget Sound Energy ("PSE"):

2<sup>nd</sup> Revision of Sheet No. 1138 – Supplemental Schedule 138: Voluntary Renewable Natural Gas Service – Purchase Rider

The purpose of this filing is to revise the availability date for service under PSE's new Supplemental Schedule 138 Voluntary Renewable Natural Gas Purchase Rider from after February 1, 2022 to December 24, 2021. The work to enhance the billing system and website to accept customer enrollment is being completed ahead of schedule.

To allow customers to participate in the Voluntary Renewable Natural Gas service when it is available this month, PSE respectfully requests that the Commission allow these tariff changes to become effective on December 24, 2021 with less than statutory notice ("LSN"). The information required by WAC 480-80-122 Tariff Changes with Less Than Statutory Notice, is contained in the attached LSN form.

The tariff sheet described herein reflects an issue date of December 10, 2021 and an effective date of January 9, 2022. Posting of the proposed tariff change for public inspection and review, as required by law and the Commission's rules and regulations, is being completed in accordance with WAC 480-90-193(1). No notice is required under the provisions of WAC 480-90-194 or - 195.
