Re: Astound Broadband, LLC – Notice of Intent to Operate Under a new “DBA”

Dear Ms. Maxwell:

Astound Broadband, LLC (“Astound” or the “Company”), a registered telecommunications carrier in Washington, hereby respectfully notifies the Washington Utilities and Transportation Commission (“Commission”) that it proposes to operate in Washington under the “doing business as” names (“DBAs”) of Astound Broadband and Astound Business Solutions. The Company is currently launching use of the Astound Broadband and Astound Business Solutions names as a brand, but intends to transition to use of the Astound Broadband and Astound Business Solutions as its operating names by mid/late spring 2022.

The Company’s customers have received written notice regarding the Company’s intention to operate under the new DBAs. These notices, supported by the Company’s customer service resources, will ensure that customers are not confused by the transition. In support of the Company’s planned use of the DBAs, Astound provides a copy of the authorization from the Washington Secretary of State for the Company to use the approved DBAs.

The Company submits this notice to update the Commission’s records. Insofar as the Commission believes that approval is required for the Company’s use of the DBAs, Astound respectfully requests that this filing be deemed a request for such approval.
