I write this message in endorsement of Mario Consiglieri who was the lead of the crew who packed my belongings for relocation from West Richland, WA, 99353 to Ft. Lupton, CO, 80621.

Mario and his crew began their work January 26, 2022 after the main packing operations were handled by the local crew the day before (Jan. 25), and finished loading our entire house-hold belongings around noon on January 27, 2022. All the while, Mario patiently answered our many questions and he and the entire crew were very pleasant and professional easing our anxiety about our move.

Under Mario's lead, his crew brought in and installed padding to protect the doorjambs and carpet runners to protect the flooring (both carpet and hardwood). The crew did a fantastic job of padding our oak bedroom and dining room furniture, as well as following up the padding with shrink wrap to hold the pads in place so they could efficiently load the items. In addition, the crew did a great job using cartons, padding, and shrink wrap to protect our breakable items (i.e., mirrors, pictures, and display cases).
