Dear Secretary Maxwell:

On February 11, 2021, the Washington Utilities and Transportation Commission (the “Commission”) granted Cable One VoIP LLC d/b/a Sparklight (the “Company”) a Registration as a Competitive Telecommunications Company in Docket No. UT-210082. As reflected in the enclosed Request for Cancellation of Registration, the Company respectfully requests that the Commission cancel the Company’s Registration. The Company has no customers in Washington, and no longer needs the Registration, which was obtained in connection with the Company’s designation as an eligible telecommunications carrier (“ETC”) for purposes of the Federal Communications Commission (“FCC”) Rural Digital Opportunity Fund (“RDOF”) auction (Auction 904). The Company also has filed to relinquish its ETC designation under separate cover. The Company respectfully requests that the Commission cancel its Registration to be effective once the ETC relinquishment proceeding is completed.
