Global Tel\*Link Corporation (the “Company”) respectfully submits this letter to notify the Washington Utilities and Transportation Commission (the “Commission”) that the Company will operate under the new doing business as (“DBA”) name “ViaPath Technologies” in Washington. Enclosed is evidence of the DBA as registered with the Department of Revenue. Please note, the legal name of the Company has not changed.

The Company was granted a registration as a telecommunications company in Docket No. UT-910397 in May 1991. Please update all Commission records to reflect the Company’s new DBA name.

The Company offers inmate calling services to correctional facilities in Washington, which allow incarcerated individuals to initiate telephone calls to their friends and family outside of the correctional facility. The DBA is reflected on the Company’s websites and interactive voice response (“IVR”) system. Only a handful of the Company’s customers receive regular monthly invoices (such as bail bondsmen, attorneys, etc.), and the DBA also will be reflected on those invoices.
