3. The temporary 1.49% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of May 2022, June 2022 and July 2022, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of September, October, November 2022

Customers who are billed quarterly for services – current month and two months in advance:

October 2022	October, November, and December 2022
November 2022	November 2022, December 2022, and January 2023
