The proposed change is to increase the Supplement from 2.76% to 2.92% in Special Fuel Surcharge Supplement No. 2.

1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: October 1, 2022.
2. The proposed changes will expire on: December 31, 2022.
3. The temporary 2.92% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of July 2022 and August 2022, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of October 2022 and November 2022.
