**NOTICE OF PENALTIES INCURRED AND DUE  
FOR VIOLATIONS OF LAWS AND RULES**

PENALTY ASSESSMENT: TR-230074  
PENALTY AMOUNT: \$1,400

The Washington Utilities and Transportation Commission (Commission) believes BNSF Railway Co. (BNSF or Company) violated Washington Administrative Code (WAC) 480-62-225 – Crossing Surfaces, which requires railroad companies to maintain highway-rail grade crossing surfaces in a state of repair.

On December 9, 2021, Commission Grade Crossing Specialist Andy McMahon issued defect notice number 8706 to BNSF related to the crossing surface at the 276<sup>th</sup> Street Northwest crossing near Stanwood, identified as USDOT 084695U. The crossing surface contained deteriorated asphalt and wooden timbers and created an uneven surface for roadway users. BNSF acknowledged the defect notice, corresponded with Commission staff (Staff) regarding this defect on five occasions in 2022, and committed to a repair date of late November 2022.

On January 11, 2023, the defect remained uncorrected. Staff sent a compliance letter directing BNSF to either provide photos of the corrected defect or provide a detailed plan for correcting the defect by January 25, 2023.

After receiving no response, Staff emailed BNSF on January 30, 2023, advising BNSF that Staff would re-inspect the crossing on February 8, 2023, and if the defect remained uncorrected, Staff would recommend administrative penalties.

Staff re-inspected the crossing on February 8, 2023, and observed that the defect had not been corrected.

Revised Code of Washington (RCW) 81.04.405 allows penalties of \$100 for each violation. In the case of an ongoing violation, every day's continuance is considered a separate and distinct violation. The violation continued for fourteen days from the deadline of Staff's compliance letter on January 25, 2023, until Staff inspected the crossing on February 8, 2023. Accordingly, the Commission hereby notifies you that it is assessing a penalty against you in the amount of \$1,400.

This information, if proven at a hearing and not rebutted or explained, is sufficient to support the penalty assessment.

Your penalty is due and payable now. If you believe the violation did not occur, you may deny committing the violation and contest the penalty through evidence presented at a hearing or in writing. Alternatively, if there is a reason for the violation that you believe should excuse you from the penalty, you may ask for mitigation (reduction) of the penalty through evidence

presented at a hearing or in writing. The Commission will grant a request for hearing only if material issues of law or fact require consideration of evidence and resolution in a hearing. Any request to contest the violation or for mitigation of the penalty must include a written statement of the reasons supporting that request. Failure to provide such a statement will result in denial of the request. *See* RCW 81.04.405.

If you properly present your request for a hearing and the Commission grants that request, the Commission will review the evidence supporting your dispute of the violation(s) or application for mitigation in a Brief Adjudicative Proceeding before an administrative law judge. The administrative law judge will consider the evidence and will notify you of his or her decision.

**You must act within 15 days after receiving this notice** to do one of the following:

- Pay the amount due.
- Contest the occurrence of the violation(s).
- Admit the violations but request mitigation of the penalty amount.

**If you do not act within 15 days**, the Commission may take additional enforcement action, including but not necessarily limited to suspending or revoking your certificate to provide regulated service, assessing additional penalties, or referring this matter to the Office of the Attorney General for collection.

RCW 9A.72.020 "Perjury in the first degree."

- (1) A person is guilty of perjury in the first degree if in any official proceeding, he or she makes a materially false statement which he or she knows to be false under an oath required or authorized by law.
- (2) Knowledge of the materiality of the statement is not an element of this crime, and the actor's mistaken belief that his or her statement was not material is not a defense to a prosecution under this section.
- (3) Perjury in the first degree is a class B felony.
