**NOTICE OF PENALTIES INCURRED AND DUE
FOR VIOLATIONS OF LAWS AND RULES**

PENALTY ASSESSMENT: TV-230080
PENALTY AMOUNT: \$400

The Washington Utilities and Transportation Commission (Commission) believes Job4Movers LLC (Job4Movers or Company) violated Washington Administrative Code (WAC) 480-15-530, Public Liability and Property Damage Insurance.

Revised Code of Washington (RCW) 81.04.405 allows penalties of \$100 for each violation. In the case of an ongoing violation, every day's continuance is considered a separate and distinct violation.

On January 18, 2023, Commission Motor Carrier Investigator Sandra Yeomans completed a follow-up safety investigation of Job4Movers and documented the following violations:

- **Four violations of WAC 480-15-530 – Operating a motor vehicle without having in effect the required minimum levels of financial responsibility coverage.** Job4Movers failed to maintain the required public liability and property damage insurance. The Company allowed its drivers to operate a commercial motor vehicle (CMV) without the required insurance on four occasions between December 17 and December 22, 2022.

The Commission considered the following factors in determining the appropriate penalties for these violations:

1. **How serious or harmful the violations are to the public.** The violations noted are serious and potentially harmful to the public. Household goods moving companies that operate CMVs without the required public liability and property damage insurance put their customers, their customers' belongings, and the traveling public at risk. These violations present safety concerns.
2. **Whether the violations were intentional.** Considerations include:
 - Whether the Company ignored Commission staff's (Staff) previous technical assistance; and
 - Whether there is clear evidence through documentation or other means that shows the Company knew of and failed to correct the violation.

On June 24, 2019, the Commission received We Got It Local Mover LLC's application for household goods moving authority. In the application, Juan Gutierrez, owner of We

Got It Local Mover LLC, acknowledged the Company's responsibility to understand and comply with applicable motor carrier safety laws and regulations.

On August 7, 2019, Juan Gutierrez attended household goods training provided by Staff and acknowledged receiving training pertaining to motor carrier safety regulations.

On June 10, 2021, We Got It Local Mover LLC filed an application with the Commission to change its corporate name to Job4Movers LLC.¹

On January 5, 2022, Staff completed a routine safety investigation of Job4Movers and provided technical assistance during the investigation. The Company knew or should have known about these requirements.

3. **Whether the Company self-reported the violations.** Job4Movers did not self-report these violations.
4. **Whether the Company was cooperative and responsive.** The Company was cooperative throughout the safety investigation.
5. **Whether the Company promptly corrected the violations and remedied the impacts.** Job4Movers corrected the violations of WAC 480-15-530 on December 29, 2022.
6. **The number of violations.** Staff identified five violation types with a total of 11 individual occurrences during its follow-up safety investigation of Job4Movers. Of those violations, Staff identified one violation type with four individual occurrences that warrant penalties in accordance with the Commission's Enforcement Policy.
7. **The number of customers affected.** Job4Movers reported traveling 17,037 miles in 2022. These safety violations presented a public safety risk.
8. **The likelihood of recurrence.** Staff provided technical assistance with specific remedies to help the Company assess how well its safety management controls support safe operations and how to begin improving its safety performance. Job4Movers was cooperative during the safety investigation and corrected the violations. In light of these factors, Staff believes the likelihood of recurrence is low.
9. **The Company's past performance regarding compliance, violations, and penalties.** On January 13, 2022, the Commission issued a Notice of Intent to Cancel the Company's household goods moving permit in Docket TV-220016 after the safety investigation of Job4Movers resulted in a proposed unsatisfactory safety rating. On January 20, 2022, the Company was penalized \$12,300 in Docket TV-220017 for safety violations of WAC 480-15-555, WAC 480-15-560, and WAC 480-15-570.

On February 14, 2022, the Commission entered Order 01, which consolidated Dockets TV-220016 and TV-220017, approved the Company's safety management plan, upgraded the safety rating to conditional, extended the Company's provisional period, assessed a reduced penalty of \$6,850, and suspended a \$3,500 portion of the penalty for a period of two years, subject to conditions. The Company paid the \$3,350 non-suspended portion of the penalty in full.

10. **The Company's existing compliance program.** Juan Gutierrez is responsible for the Company's safety compliance program.

11. **The size of the Company.** The Company employs two drivers and operates two CMVs. The Company reported \$103,180 in gross revenue for 2022.

The Commission's Enforcement Policy provides that some Commission requirements are so fundamental to safe operations that the Commission will issue mandatory penalties for each occurrence of a first-time violation.² The Commission generally will assess penalties by violation category, rather than per occurrence, for first-time violations of those critical regulations that do not meet the requirements for mandatory penalties. The Commission will assess penalties for any equipment violation meeting the Federal Motor Carrier Safety Administration's "out-of-service" criteria and for repeat violations of critical regulations, including each occurrence of a repeat violation.

The Commission has considered these factors and determined that it should penalize Job4Movers \$400 (Penalty Assessment), calculated as follows:

- Four violations of WAC 480-15-530 – Operating a motor vehicle without having in effect the required minimum levels of financial responsibility coverage. The Commission assesses a penalty of \$100 for each occurrence of this acute violation, for a total of \$400.

This information, if proven at a hearing and not rebutted or explained, is sufficient to support the Penalty Assessment.

Your penalty is due and payable now. If you believe any or all the violations did not occur, you may deny committing the violation(s) and contest the penalty through evidence presented at a hearing or in writing. Alternatively, if there is a reason for any or all the violations that you believe should excuse you from the penalty, you may ask for mitigation (reduction) of the penalty through evidence presented at a hearing or in writing. The Commission will grant a request for hearing only if material issues of law or fact require consideration of evidence and resolution in a hearing. Any request to contest the violation(s) or for mitigation of the penalty must include a written statement of the reasons supporting that request. Failure to provide such a statement will result in denial of the request. *See* RCW 81.04.405.

If you properly present your request for a hearing and the Commission grants that request, the Commission will review the evidence supporting your dispute of the violation(s) or application for mitigation in a Brief Adjudicative Proceeding before an administrative law judge. The administrative law judge will consider the evidence and will notify you of their decision.

You must act within 15 days after receiving this notice to do one of the following:

- Pay the amount due.
- Contest the occurrence of the violation(s).
- Admit the violations but request mitigation of the penalty amount.

If you do not act within 15 days, the Commission may take additional enforcement action, including but not necessarily limited to suspending or revoking your certificate to provide regulated service, assessing additional penalties, or referring this matter to the Office of the Attorney General for collection.

a) I ask for a hearing to present evidence on the information I provide above to an administrative law judge for a decision.

OR b) I ask for a Commission decision based solely on the information I provide above.
