**YOU MUST RESPOND WITHIN 15 DAYS OF THIS NOTICE**

The Washington Utilities and Transportation Commission (Commission) believes that Taylor's Excavators, Inc., (Taylor's Excavators or Company) violated Revised Code of Washington (RCW) 19.122.055(1)(a) by failing to notify the one-number locate service and caused damage to an underground gas facility.

RCW 19.122.055(1)(a) states, in part, that excavators who fail to notify a one-number locator service and causes damage to an underground gas facility is subject to a civil penalty of not more than \$10,000 for each violation.

Commission staff (Staff) conducted an investigation that included reviewing damage reports, investigation reports, a review of the One Call Center database, and communications with the Company. The documents reviewed identified a natural gas event that involved Taylor's Excavators damaging a natural gas facility while excavating without a valid locate ticket.

The Commission reviewed findings and recommendations made by Commission staff and hereby notifies you that it is assessing a \$2,500 penalty (Penalty Assessment) against you on the following grounds:

**Alleged Violation(s):**

On October 26, 2022, Taylor's Excavators was excavating at 1010 16<sup>th</sup> Ave, Sultan, Washington. While excavating, Taylor's Excavators workers struck and damaged an underground Puget Sound Energy (PSE) natural gas facility. The Damage Information Reporting Tool (DIRT) report submitted by PSE on December 7, 2022, indicated that Taylor's Excavators was excavating without a valid request to locate underground utilities.

**Analysis:**

The alleged violations concern RCW 19.122.055(1)(a), which states, in part, that an excavator must contact the one-number locate center before beginning excavation. On

October 26, 2022, Taylor's Excavators were excavating to install water meter boxes when it struck a PSE underground natural gas line. The Gas First Responder (GFR) report from PSE indicated this gas line had been installed two weeks prior and was under pressure testing at the time it was hit. The GFR and ELM reports both indicated Taylor's Excavators had a previous locate ticket #22364834, but it expired on September 30, 2022. At the time this damage occurred, there was no valid locate ticket for the address.

The Commission considered the following factors in determining the appropriate penalty amount for the violation:

1. **How serious or harmful the violation is to the public.**  
This incident could have caused more severe harm to other employees, or the public, and could have resulted in additional undue expenses and hardships.
2. **Whether the violation is intentional.**  
The violation does not appear to be intentional, but rather due to negligence by Taylor's Excavators. Over the past 12 months, Taylor's Excavators has submitted 67 locate requests to the One Call Center. This indicates Taylor's Excavators is aware of the requirements of the Dig Law.
3. **Whether the company self-reported the violation.**  
Taylor's Excavators did not self-report the violation. The Commission became aware of the violation when PSE filed a DIRT report following the damage incident.
4. **The likelihood of recurrence.**  
The likelihood of recurrence depends on Taylor's Excavators actions going forward, and its willingness to notify the one-number locate service before beginning excavation and maintain the validity of those locate tickets throughout the duration of its projects.
5. **The Company's previous violations and penalties.**
  - **Warning Letters**
    - On January 19, 2017, September 20, 2017, November 19, 2019, May 29, 2020, and April 15, 2021, the Commission mailed Alleged Violation of Washington Dig Law letters to Taylor's Excavators. The letters included detailed information about Washington state's underground utility damage prevention act, requirements for submitting utility locate requests before excavating, and the possibility of penalties for each violation.
  - **Penalty Assessments**
    - On March 16, 2018, the Commission issued Taylor's Excavators a Penalty Assessment of \$1,000 for one violation of RCW 19.122.055(1)(a) - DG-180218.
    - On March 29, 2022, the Commission issued Taylor's Excavators a Penalty Assessment of \$1,000 for one violation of RCW 19.122.055(1)(a) - DG-220070.

The Commission has considered these factors and determined that it should penalize Taylor's Excavators as follows:

- \$2,500 penalty for one violation of RCW 19.122.055(1)(a) with an offer to suspend a \$2,000 portion of the penalty for one year, and then waive it, subject to the conditions that:
  - 1) Company supervisors and field crew responsible for excavation complete Dig Safe Training provided through the National Utility Contractors Association (NUCA) within 90 days of this Penalty Assessment;
  - 2) The Company must submit documentation of that attendance to the Commission within 5 days of attending training; and
  - 3) The Company must not commit any further violations of RCW 19.122 within 12 months of the date of this Penalty Assessment.

These facts, if proven at a hearing and not rebutted or explained, is sufficient to support the Penalty Assessment.

Your penalty is due and payable now. If you believe the violation did not occur, you may deny committing the violation and contest the penalty through evidence presented at a hearing or in writing. Or, if there is a reason for the violation that you believe should excuse you from the penalty, you may ask for mitigation (reduction) of the penalty through evidence presented at a hearing or in writing. The Commission will grant a request for a hearing only if material issues of law or fact require consideration of evidence and resolution in a hearing. Any request to contest the violation or for mitigation of the penalty must include a written statement of the reasons supporting that request. Failure to provide such a statement will result in denial of the request. *See* RCW 81.04.405.

If you properly present your request for a hearing and the Commission grants that request, the Commission will review the evidence supporting your dispute of the violation or application for mitigation in a Brief Adjudicative Proceeding before an administrative law judge. The administrative law judge will consider the evidence and will notify you of their decision.

**You must act within 15 days after receiving this Penalty Assessment** to do one of the following:

- Pay the \$2,500 penalty amount due; or
- Pay \$500 and notify the Commission that you accept the offer to suspend a \$2,000 portion of the penalty amount subject to the following conditions:
  - Taylor's Excavators management and the field crew responsible for excavation must complete NUCA Dig Safe Training (<https://utc-9183.quickbase.com/db/bpkt6vndh>) within 90 days of service of this Penalty Assessment; and
  - **The Company must submit documentation of that attendance to the Commission within 5 days of attending training;** and
  - Taylor's Excavators must not incur any additional violations of RCW 19.122 within 12 months of the date of this Penalty Assessment; or
- Request a hearing to contest the occurrence of the violations; or
- Request mitigation to reduce the amount of the penalty.

- [ ] 3. **Contest the violation.** I believe that the alleged violation did not occur for the reasons I describe below (**if you do not include reasons supporting your contest here, your request will be denied**):
- [ ] a) I ask for a hearing to present evidence on the information I provide above to an administrative law judge for a decision.  
OR [ ] b) I ask for a Commission decision based solely on the information I provide above.
- [ ] 4. **Request mitigation.** I admit the violation, but I believe that the penalty should be reduced for the reasons set out below (**if you do not include reasons supporting your application here, your request will be denied**):
- [ ] a) I ask for a hearing to present evidence on the information I provide above to an administrative law judge for a decision.  
OR [ ] b) I ask for a Commission decision based solely on the information I provide above.

- (1) A person is guilty of perjury in the first degree if in any official proceeding he or she makes a materially false statement which he or she knows to be false under an oath required or authorized by law.

- (3) Perjury in the first degree is a class B felony.
