Cascade Natural Gas Corporation ("Cascade" or "Company") files the following revisions to its Tariff, WN U-3, stated to become effective May 26, 2023:

The purpose of this housekeeping filing is twofold. First the Company requests to remove tariff sheets that have had all text removed in previous advice filings. Second, the Company seeks to

repurpose Schedule 590, Temporary Gas Cost Amortization, which had all text removed in UG-220702. Schedule 590 is renamed Gas Cost Rate Adjustment and is revised to list the weighted average cost of gas (WACOG) for each rate schedule and the Schedule 595, Temporary Technical Adjustment. The references to WACOG are removed from the individual service rate schedules and, instead, Schedule 590 is cited. The Temporary Gas Cost is removed from Schedule 595 and moved to proposed Schedule 590. These revisions create an administrative efficiency for purchased gas adjustment (PGA) filings and will allow the Company the flexibility to revise sheets that might otherwise be suspended in a PGA filing. The Company has been in a position where suspended sheets needed to be revised but could not be.

Text on the rate schedule sheets is reorganized and restated to improve clarity.

The Table of Contents is reorganized for clarity and revised to reflect removal of Schedule 581, the removal of content from Schedule 595, and the renaming of Schedule 590.
