# YOU MUST RESPOND WITHIN 15 DAYS OF THIS NOTICE

The Washington Utilities and Transportation Commission (Commission) believes that Ramex Excavating LLC (Ramex or Company) violated Revised Code of Washington (RCW) 19.122.055(1)(a) by failing to notify the one-number locate service and caused damage to an underground gas facility.

RCW 19.122.055(1)(a) states, in part, that excavators who fail to notify a one-number locator service and cause damage to an underground gas facility are subject to a civil penalty of not more than \$10,000 for each violation.

Commission staff (Staff) conducted an investigation that included reviewing damage reports, investigation reports, a review of the One Call Center database, and communications with the Company. The documents reviewed identified a natural gas event that involved Ramex damaging a natural gas facility while excavating without a valid locate ticket.

The Commission reviewed findings and recommendations made by Staff and hereby notifies you that it is assessing a \$1,000 penalty (Penalty Assessment) against you on the following grounds:

#### 1. **Alleged Violation:**

On February 3, 2023, Ramex was excavating at 1534 NW 59<sup>th</sup> St., Seattle, Washington. While excavating, Ramex workers struck and damaged an underground Puget Sound Energy (PSE) natural gas facility. The Damage Information Reporting Tool (DIRT) report submitted by PSE on March 17, 2023, indicated that Ramex was excavating without a valid request to locate underground utilities.

#### 2. **Analysis:**

The alleged violation concerns RCW 19.122.055(1)(a), which states, in part, that an excavator must contact the one-number locate center before beginning excavation. On February 3, 2023, an ELM Utilities Services (ELM) locator arrived at 1534 NW 59<sup>th</sup> St.,

Seattle to complete locates for ticket #23035595. When the locator arrived, it noticed an exposed gas line and notified PSE. When the PSE Gas First Responder (GFR) responded to repair the damaged line, they initially identified the property owner as responsible for the damage. After further review, PSE communicated with Ramex, who admitted it caused the damage while doing foundation excavation work. Ramex indicated that it bent the line back to get it out of the way. PSE reported detailed communication with the Company regarding safety concerns. Staff reviewed several emails from PSE and ELM indicating Ramex was liable. When informed of this allegation by Staff, Ramex denied being responsible for the damage. Staff notified Ramex of the communications from PSE stating Ramex had admitted to the damage and taken responsibility for it. Staff requested a response from the Company. Ramex has not responded. Staff reviewed the One Call Ticket Center database and did not find a locate ticket for Ramex for this location.

The Commission considered the following factors in determining the appropriate penalty amount for the violation:

# 1. How serious or harmful the violation is to the public.

These incidents could have been significantly more harmful to Company workers, utility technicians, nearby homeowners, and the public, and could have resulted in severe injury and/or loss of property.

#### 2. Whether the violation is intentional.

The violations appear to be due to negligence rather than a lack of knowledge of Washington state's dig law. In the past 12 months, Ramex has called in 56 requests to the One Call Center for locates. This demonstrates the Company's knowledge of its requirements and responsibility to contact the one-number locate service before beginning excavation.

#### 3. Whether the company self-reported the violation.

Ramex did not self-report the violation. The Commission became aware of the violation when PSE filed the DIRT report following the damage incident.

#### 4. The likelihood of recurrence.

Ramex's likelihood of recurrence depends on the Company's actions going forward and its willingness to notify the one-number locate service every time before beginning excavation.

### 5. The Company's previous violations and penalties.

On July 8, 2022, and October 31, 2022, the Commission mailed Alleged Violation of Washington Dig Law letters to Ramex. The letters included detailed information about Washington State's underground utility damage prevention act, requirements for submitting utility locate requests before excavating, and the possibility of penalties for each violation. The Commission mailed the letters after receiving reports of damages caused by Ramex that occurred because the Company failed to submit a request to locate underground utilities before excavating.

The Commission has considered these factors and determined that it should penalize Ramex as follows:

- \$1,000 penalty for one violation of RCW 19.122.055(1)(a) with an offer to suspend an \$800 portion of the penalty for one year, and then waive it, subject to the conditions that:
  - 1) Company supervisors and field crew responsible for excavation complete Dig Safe Training provided through the National Utility Contractors Association (NUCA) within 90 days of this Penalty Assessment;
  - 2) The Company must submit documentation of that attendance to the Commission; and
  - 3) The Company must not commit any further violations of RCW 19.122 within 12 months of the date of this Penalty Assessment.

These facts, if proven at a hearing and not rebutted or explained, are sufficient to support the Penalty Assessment.

Your penalty is due and payable now. If you believe the violation did not occur, you may deny committing the violation and contest the penalty through evidence presented at a hearing or in writing. Or, if there is a reason for the violation that you believe should excuse you from the penalty, you may ask for mitigation (reduction) of the penalty through evidence presented at a hearing or in writing. The Commission will grant a request for a hearing only if material issues of law or fact require consideration of evidence and resolution in a hearing. Any request to contest the violation or for mitigation of the penalty must include a written statement of the reasons supporting that request. Failure to provide such a statement will result in denial of the request. *See* RCW 81.04.405.

If you properly present your request for a hearing and the Commission grants that request, the Commission will review the evidence supporting your dispute of the violation or application for mitigation in a Brief Adjudicative Proceeding before an administrative law judge. The administrative law judge will consider the evidence and will notify you of their decision.

# You must act within 15 days after receiving this Penalty Assessment to do one of the following:

- Pay the \$1,000 penalty amount due; or
- Pay \$200 and notify the Commission that you accept the offer to suspend an \$800 portion of the penalty amount subject to the following conditions:
  - o Ramex management and the field crew responsible for excavation must complete NUCA Dig Safe Training (<a href="https://utc-9183.quickbase.com/db/bpkt6vndh">https://utc-9183.quickbase.com/db/bpkt6vndh</a>) within 90 days of service of this Penalty Assessment; and
  - The Company must submit documentation of that attendance to the Commission; and
  - o Ramex must not incur any additional violations of RCW 19.122 within 12 months of the date of this Penalty Assessment; or
- Request a hearing to contest the occurrence of the violations; or
- Request mitigation to reduce the amount of the penalty.

- (1) A person is guilty of perjury in the first degree if in any official proceeding he or she makes a materially false statement which he or she knows to be false under an oath required or authorized by law.
