Puget Sound Energy's Electric Tariff Revision

Dear Executive Director Maxwell:

Pursuant to RCW 80.28.060, and WAC 480-80-101 and -105, please find enclosed for filing the following proposed revisions to the WN U-60, tariff for electric service of Puget Sound Energy ("PSE" or "the Company"):

The purpose of this filing is to revise Schedule 53 Street Lighting Service to reflect the current standard street lighting equipment from High Pressure Sodium ("HPS") and Metal Halide luminaires to Light Emitting Diode ("LED") luminaires.

Due to the electric lighting technology evolution, HPS and Metal Halide luminaires are no longer being manufactured. Going forward, LED luminaires will be considered the standard luminaire for the purposes of Schedule 53. Currently, approximately 40% of luminaires under PSE's Schedule 53 street lighting service are already equipped with LED luminaires.

Additionally, this filing adds clarifying language regarding legacy street lights with street light circuitry located underground that have been receiving Schedule 53 street lighting service on or prior to June 1, 1998. These legacy street lights will remain under Schedule 53 service when they are converted to LED. However, when a street light pole associated with a legacy underground-circuitry street light is modified at customer request, PSE may switch to the legacy street light to another appropriate schedule.
