On January 31, 2022, PSE filed revisions to its tariff, WN U-60, for electric service, as a general rate case and its first multi-year rate plan (“MYRP”)<sup>1</sup>, filed pursuant to RCW 80.28.425. In its initial filing, PSE proposed a three-year rate plan for the years 2023, 2024, and 2025. On December 22, 2022, the Commission issued Order 24/10 (“the Order”), approving settlements which provided for a two-year MYRP.

The purpose of this housekeeping filing is to revise electric Schedules 141N, 141R, and 142 to remove the end date of December 31, 2024 for rates that have been approved to go into effect on January 1, 2024. The end date was initially included on the tariff sheets described herein as a part of PSE’s proposal of a three-year MYRP and is no longer relevant as there will be no new column of previously approved rates beginning in 2025.

The tariff sheets described herein reflect an issue date of November 1, 2023, and effective date of December 1, 2023. Posting of proposed tariff changes, as required by law and the Commission’s rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-100-193.
