GRADE CROSSING PROTECTIVE FUND 2023 - 2025 GRANT APPLICATION IMPROVEMENTS AT PASSIVE RAILROAD CROSSINGS

This GCPF Application covers our railroad line CWW LLC in Walla Walla Washington. Most crossings we are asking for upgrades at are all Public or Signalized crossings with a select few of Private crossings.

Our CWW line is an Industrial Lead that hauls freight only. All crossings that are in need of upgrades have deteriorating signs/posts or missing all together their proper signs to meet code. We need to upgrade these crossings to meet code with FRA/UTC and to increase visibility and awareness to the Public when approaching these Railroad Crossings.

Back in 2021 we were approved for a Passive Railroad Crossing Grant through the UTC, which we carried out within the time frame that was set. We've also been approved other GCPF's by UTC through-out the last five years.

Columbia Rail will contribute: Labor.
UTC will contribute: Funds for Materials only.
We are requesting: \$15, 975
Each Crossing on average will cost: \$159.75
Timeline of Completion: June 1st, 2024.
