Dear Executive Director and Secretary,

Pursuant to WAC 480-120-083, this letter is submitted on behalf of Telecom Management, Inc. dba Pioneer Telephone (“Telecom Management” or “Company”) to notify the Commission of the Company’s intent to discontinue service to all customers in Washington. Telecom Management was issued a Registration as a Competitive Telecommunications Company in Docket UT-041341 on August 10, 2004.

Pursuant to WAS 480-120-083 (3), Telecom Management provides the following information:

1. **Name of Telecommunications Company:** Telecom Management, Inc. dba Pioneer Telephone is located at 100 Main Street, #105, Saco, Maine, 04072.
2. **Date of Planned Service Continuance:** Telecom Management, Inc. dba Pioneer Telephone will discontinue services effective immediately upon regulatory approvals. As of December 31, 2022, the Company had no active customers in service.
3. **Number of Impacted Customers and Their Location:** As of December 31, 2022, Telecom Management did not have any customers in service.
4. **Customer Notice:** Customer notice is not necessary because as of December 31, 2022, Telecom Management did not have any customers in service.
5. **Notice to State 911 program:** This letter is being sent to the State E911 Coordinator to satisfy the requirement of WAS 480-12-083 (2)(b).
6. **Notice to Incumbent Local Exchange Carriers (“ILECs”):** Not applicable. The Company is a reseller and does not purchase unbundled network elements from any ILEC.

8. **Notice to National Number Administrator:** Not applicable. Telecom Management is not assigned numbers directly because they are a reseller.
