*** Company proposes to change (Include Title of Provision, Tariff number and Sheets/Pages being changed):**
Tariff #10, add unlocking/unlatching rates to residential services on Item 100, pages 22-A, 24-A, & 26-A.

*** Present provisions are:**
45 day notice to customers for all tariff changes per RCW 81.28.050.

*** Proposed changes are:**
Notify customers on the first bill as stated in WAC 480-70-271 (2)(a). This would occur February 1, 2024 and to notify Commissioners with 7 day notice per WAC 480-70-262(2).

*** Explain why the company is proposing this tariff revision:**
Notifying customers on the first bill has been the historic practice and follows WAC 480-70-271(2)(a).

*** Explain why the Commission should allow this tariff revision to take effect with less than 30 days' notice (45 days' notice for solid waste):**

A Tariff revision where a new service is added has historically required 7 day notice to the Commissioners per WAC 480-70-262(2). We are requesting that we follow this historic practice and add the new service beginning February 1, 2024. Additionally we would like to notify customer's on their February 1, 2024 bill per WAC 480-70-271(2)(a) and begin offering and charging for unlocking/unlatching services.
