**Re: Request for Cancellation of Registration of Electric Lightwave, LLC d/b/a Allstream**

Dear Executive Director Killip:

Attached for filing is a Request for Cancellation of the Registration of Electric Lightwave, LLC d/b/a Allstream ("Electric Lightwave") granted in Docket No. UT-970032, as amended in Docket. Nos. UT- 971128 and UT-970874, and granted competitive classification in Docket No. UT- 970874.1998. As described in Docket No. UT-220919, Electric Lightwave was consolidated into its parent Zayo Group, LLC on December 31, 2023, and no longer exists as a separate corporate entity or provides telecommunications services in Washington. All of Electric Lightwave's Washington customers are served by Zayo Group LLC pursuant to its Registration granted in Docket No. UT-110349. Accordingly, Electric Lightwave does not require its Registration and the Commission should cancel it effective January 1, 2024, at the earliest possible date.
