 PSE's Natural Gas Tariff Filing - Filed Electronically**

Dear Executive Director Killip:

Puget Sound Energy ("PSE") hereby submits proposed revisions to rates under natural gas Schedule 111, Greenhouse Gas Emissions Cap and Invest Adjustment. This tariff filing, pursuant to RCW 80.28.060 and Chapter 480-80 WAC, includes the following natural gas tariff sheets:

The purpose of this filing is to change the implementation date that the monthly State Carbon Reduction Credit may not exceed the amount of the State Carbon Reduction Charge from May 1, 2024, to April 1, 2024.

Effective December 1, 2023, the Commission approved a revision to Schedule 111<sup>1</sup> to clarify that any the amount of the non-volumetric monthly State Carbon Reduction Credit ("Credit") shall not exceed a customer's total monthly State Carbon Reduction Charge ("Charge")<sup>2</sup>. This was to ensure the amount of the non-volumetric monthly Credit does not exceed the customer's total monthly Charge, as PSE had started to experience below average usage customers receiving excess benefits. In that previously approved tariff filing, the Company set a target implementation date of May 1, 2024, so that it could complete the necessary programming of its billing system in a timely manner. However, this necessary programming was completed more

quickly than the Company originally anticipated, and it is now prepared to implement the changes effective April 1, 2024.

The tariff sheet described herein reflects an issue date of February 29, 2024 and effective date of March 30, 2024. Posting of proposed tariff changes, as required by WAC 480-90-193, is being accomplished by posting the proposed tariff sheets on the PSE web site coincident with the date of this transmittal letter.
