This schedule is available in all Water Service Areas served by the Utility and at the Utility's option and capability to maintain Department of Health's standards of quantity and quality.

#### **Applicable**

Applicable to any customer or customer on the Grasslands Park, Happy Trails, Turf Trails or Green Trails water system, WFI AB 290, AD 115, AB 914K, AB 594K.

#### **Conditions**

The change for this service is not subject to cancellation or reduction for seasonal or temporary periods unless seasonal rates apply per this tariff. This change will be the monthly minimum bill for this class of service and will be in addition to other charges as provided in this tariff.

This surcharge is to fund the cost incurred for capital improvements to the irrigation system, in order to maintain water quality and quantity that meets Department of Health's drinking water standards.
