Company proposes to change Tariff Number 14

The company requests Commission approval to amend its filed Tariff Number 14 on Less Than Statutory Notice to increase its Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$2.7071 per gallon for the base period to \$3.9995 per gallon current price. The proposed change is to implement a 0.05% surcharge in Supplement 4. Special Fuel Surcharge Supplement No. 3 will expire on July 31, 2024. The company request less than statutory notice allowing the customers to be noticed on the first bill as previously allowed per WAC 480-70-271(2)(a).

2. The proposed changes will expire on: September 30, 2024.
3. The temporary 0.05% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of May 2024, and June 2024, to be collected from customers as follows:

Customers who are billed monthly for services in arrears: The fuel surcharge applies to all services provided in the months of August 2024 and September 2024.

Customers who are billed bi-monthly for services – current month and one month in advance:

Customers Billed in Month end:	Fuel Surcharge applies to all services provided in the months of:
August 31, 2024	August 2024, and September 2024
September 30, 2024	September 2024, and October 2024
