RE: TN-240561 - Cancellation of Certificate NPC071293 Due To Insufficient Proof of Insurance

Dear Triple Point Recovery Services:

On June 12, 2024, the Washington Utilities and Transportation Commission (Commission) notified you that your transportation certificate would be canceled unless you submitted acceptable proof of insurance by July 17, 2024. Our records show that you failed to submit acceptable proof of insurance by that deadline. As a consequence, the Commission has CANCELED your certificate. You must immediately CEASE all operations associated with this certificate. If you operate without a valid certificate, the commission may take enforcement action against you.

**You have the right to a hearing.** If you believe the Commission should not have canceled your certificate, you may ask the Commission to schedule a hearing before an administrative law judge. At the hearing the only issue the Commission will address is whether you had proof of insurance on file to avoid cancellation. The Commission must receive your request within 14 days after the date of this letter.

You may apply to reinstate your certificate. Download the reinstatement application at <a href="https://www.utc.wa.gov">www.utc.wa.gov</a>. To locate application instructions, type "File Your Transportation Application Electronically" in the site search bar, and select this link. Then, click on the appropriate industry application.
