Re: Advice Letter Regarding Name Change from Consolidated Communications of Washington Company, LLC d/b/a Lightcurve to Evergreen Washington Connect, LLC d/b/a Lightcurve

Dear Executive Director Killip:

Evergreen Washington Connect, LLC d/b/a Lightcurve (formerly known as Consolidated Communications of Washington Company, LLC d/b/a Lightcurve) (the "Company") notifies the Commission that the Company's current name is "Evergreen Washington Connect, LLC d/b/a Lightcurve" as a result of a name change effective August 12, 2024. The Company requests that the Commission update its records, including the Company's authorization,¹ to reflect the name change, and to the extent necessary, to approve the name change. The Company continues to conduct its business under the trade name "Lightcurve" as notified in the Advice Letter filed in Docket No. UT-240438.

Washington Department of Revenue documentation reflecting the new legal name and d/b/a of "Lightcurve" is provided as Attachment A. The Company will separately submit tariff filing(s) to reflect the name change.

¹ In Washington, the Company is authorized to operate as an incumbent telecommunications service provider pursuant to the Order issued in Docket UT-190077, effective March 1, 2019. The Company also obtained designation as an Eligible Telecommunications Carrier ("ETC").
