On 9/9/24 Hildebrand Concrete was found installing concrete forms and stakes for new sidewalk and ADA ramps without a locate ticket. NWN personnel spoke to the crew and advised them of the dig law violation, educated them and advised them to stop work until requesting a locate ticket. They were subcontracted by the City of Ridgefield and city employees have been notified of the dig law violations in effort to assist in gaining Hildebrand's compliance. NWN personnel went back the following day on 9/10/24 and discovered Hildebrand continuing to excavate without a locate request. Hildebrand previously damaged a polyethylene gas main on 5/22/24 at 905 NE 136th Ave Vancouver, WA, also without a locate ticket. They were educated and offered training at that time. NWN has researched Hildebrand's locate ticket request history and discovered one locate ticket request in the last 13 months. **On 9/11, Hildebrand Concrete was found again working without a valid locate ticket, address 4905 NE 122nd Avenue, Vancouver 98682.**
