RE: Mosaic Networx, LLC – Discontinuance of Competitive Classification Services

Dear Executive Director and Secretary,

Pursuant to WAC 480-120-083, this letter is submitted on behalf of Mosaic Networx, LLC (Mosaic Networx or "Company") to notify the Commission of the Company's intent to discontinue its registration under the competitive classification. Mosaic Networx was issued a Registration as a Competitive Telecommunications Company in Docket UT-110661 on May 14, 2011. They will continue to provide non-regulated services.

Pursuant to WAS 480-120-083 (3), Mosaic Networx provides the following information:

1. **Name of Telecommunications Company:** Mosaic Networx, LLC is located at 700 Larkspur Landing Circle, Suite 214, Larkspur, CA, 94939
2. **Date of Planned Service Continuance:** Mosaic Networx will discontinue regulated services effective immediately upon regulatory approvals. As of December 31, 2023, the Company had no active customers in service under the regulatory certification.
3. **Number of Impacted Customers and Their Location:** As of December 31, 2023, Mosaic Networx did not have any customers in service under the competitive classification.
4. **Customer Notice:** Customer notice is not necessary because as of December 31, 2023, Mosaic Networx did not have any customers in service under the competitive classification.
5. **Notice to State 911 program:** This letter is being sent to the State E911 Coordinator to satisfy the requirement of WAS 480-12-083 (2)(b).
6. **Notice to Incumbent Local Exchange Carriers ("ILECs"):** Not applicable. The Company is a reseller and does not purchase unbundled network elements from any ILEC.

7. **Notice to Companies Providing Resold Services:** The Underlying provider is aware of the discontinuance of the regulated services and additional notice is not required.
8. **Notice to National Number Administrator:** Not applicable. Mosaic Networx is not assigned numbers directly because they are a reseller.
