SCHEDULE 139 VOLUNTARY LONG TERM RENEWABLE ENERGY PURCHASE RIDER

1. PREFACE:

- a. The Company and many Customers have worked together to encourage the development of Renewable Energy resources that (i) will provide clean energy to Customers at a long-term contracted rate, (ii) support the local economy, and (iii) could be publicized and leveraged for external benefit.
- b. This Schedule is designed to provide Customers a voluntary opportunity to purchase Renewable Energy as established by RCW 19.29A.090.
- c. Service under this Schedule is provided through: 1) the purchase of Renewable Energy from resources the Company owns or contracts for and delivered to the Company's Balancing Authority Area, and 2) Renewable Energy Credits, where applicable, obtained by the Company and transferred to the Customer that have been created with the electricity production.
- d. As this is a retail product, the Renewable Energy Credits, when available, must be retired by the Customer in WREGIS or they may be retired by the Company on behalf of the Customer.

2. **AVAILABILITY:**

a. Service under this Schedule is available after January 1, 2017, to Customers taking Electric Service on any of the following schedules: 24, 25, 26, 31, 43, 46, 49 and 558.

b. At the time an Enrollment Request is submitted, Customers must have a minimum aggregated load of 10,000,000 kWh annually with PSE, or be a municipal, county, state or federal institution. Customers may choose which service address(es) to subscribe to this service. Customers must contract for 100% of the load of all meters located at each service address under contract for Renewable Energy.

AVAILABILITY: This Schedule is available to a non-residential Customer with a permanently installed electric meter or meters which serves the primary purpose of providing Electric Service to Electric Vehicle Supply Equipment (EVSE) for a depot or fleet charging station and except as otherwise provided by this Schedule, on the Terms and Conditions set forth in the Schedule and in the applicable Schedule 24, 25, 26, or 31 of this tariff. Service under this Schedule may also be referred to as: Up & Go Electric for Fleet.

- Service under this Schedule will be available on or after December 31, 2025, for Energy Only, Demand Only, and Energy and Demand Pricing Options, up to the limits noted below. Service under this Schedule will be available on or after January 1, 2027, for the Subscription Pricing Option.
- Enrollment in Schedule 558 is limited to 35 Points of Delivery or a total aggregated peak demand of 3 Megawatts (MW) on a monthly basis, whichever is reached first during enrollment. The aggregate monthly peak demand will be calculated using recent historical data. For new participants without historical data, the Company will use best available estimates to determine demand.
- Eligible Customers must have the appropriate metering, including a demand meter, installed by the Company and charging equipment available for the participating Premise, as determined solely by the Company.
- Customers taking service under Schedules 150, 667, or 686 of this tariff are not eligible for this service.
- The Company has sole discretion to limit and control individual Customer participation based on the need/criteria to conduct studies, measurements, and evaluations of participant responses.

ENROLLMENT: The Customer must complete the Company's enrollment process to participate in this service. Initiation of service under this Schedule will occur following acceptance and processing of the enrollment requests received by the Company.

TERMS AND CONDITIONS:

- The Customer must consent to be contacted by the Company, its affiliates, or third parties for the purposes of transportation electrification load and program studies.
- The Customer must provide the Company access to the meter at all time. Should any meter fail to register or register accurately the amount of electricity used by the Customer during Peak and Off-Peak time periods, the amount of such use will be estimated by the Company from the best available information, as determined by the Company. The Customer understands that the monthly bill will include interval readings but that by the nature of this optional service may not display beginning and ending meter readings for the billing period.
- The Customer must consent for their information, specific to usage under this Schedule to be studied in order to provide feedback to the Customer on their usage and how they may optimize potential savings by changing usage behavior.
- By virtue of this service being part of the Company's primary purpose, Customers are deemed to be subscribing to this service, and the Company may disclose customer information to third parties when necessary to perform and operate this service.
- A Customer must be enrolled in Schedule 558 for at least six (6) months. After six (6) months, the Customer may change to Schedule 24, 25, 26, or 31 (as applicable).
- A Customer must be enrolled in a Pricing Option for at least six (6) months. After six (6) months the Customer may change to a different Pricing Option, by notifying the Company by telephone or in writing. The change request will be implemented after the Company processes the request and necessary billing adjustments are made, within one or two billing cycles.

MONTHLY RATE GROUPS:

Energy Only Pricing Option:

- Rate Group 1 (RG-1E): Customers whose Energy usage is less than 36,500 kWh per month.
- Rate Group 2 (RG-2E): Customers whose Energy usage is equal to and between 36,500 kWh per month and 255,500 kWh per month.
- Rate Group 3 (RG-3E): Customers whose Energy usage is greater than 255,500 kWh per month.

Demand Only Pricing Option, Energy and Demand Pricing Option, and Subscription Pricing Option:

- Rate Group 1 (RG-1D): Customers whose Demand usage is less than 50 kW per month.
- Rate Group 2 (RG-2D): Customers whose Demand usage is equal to and between 50 kW per month and 350 kW per month.
- Rate Group 3 (RG-3D): Customers whose Demand usage is greater than 350 kWh per month.

TERMINATION BY CUSTOMER: A Customer must be enrolled in Schedule 558 for at least six (6) months. After six (6) months, the Customer may change to Schedule 24, 25, 26, or 31, depending upon eligibility (as applicable), by notifying the Company upon notification by telephone or in writing received by the Company prior to billing and effective in the Customer's next billing cycle. Although the Customer may change to Schedules 24, 25, 26, or 31, subsequent requests to take service under this Schedule may be denied by the Company.

BILLING DEMAND:

The Billing Demand for each pricing option is determined as follows:

- Energy and Demand Pricing Option: The highest demand established during the billing month, with either the Peak or Off-Peak Charge applied depending on when the peak demand occurred.
- Demand Only Pricing Option: Both Peak and Off-Peak Charges are applied separately to the two individual periods based on when each peak was determined during the Peak and Off-Peak time periods.
- Subscription Pricing Option: The highest monthly demand is divided by the corresponding Rate Group fixed kW to determine the number of multiples of the Subscription Charge, rounded up to the nearest whole number. Example: A customer has a demand of 32 kW and falls within Rate Group 1-D (RG-1D), with a price of \$360 per 5 kW. Calculation would be 32 kW ÷ 5 kW = 6.4, rounded up to 7.0. Thus, the monthly Subscription Charge per fixed kW is 7 x \$360 = \$2,520.

PRIMARY VOLTAGE: All necessary wiring, transformers, switches, cut-outs and protection equipment beyond the Point of Delivery shall be provided, installed and maintained by the Customer, and such service facilities shall be of types and characteristics acceptable to the Company. The entire service installation, protection coordination, and the balance of the load between phases shall be approved by Company engineers.

CUSTOMER INFORMATION: By virtue of this service being part of the Company's primary purpose of providing electric service to its Customers, the Customer grants to the Company the right to use their personal information, relative to this service, and the Company may disclose personal information to third parties. Personal information includes, but is not limited to, contact information such as telephone number or email address.
