CLEAN FUEL STANDARD CREDITS FUNDED PRODUCTS AND SERVICES

AVAILABILITY:

Throughout its electric service territory the Company, at its discretion, may provide optional Clean Fuel Standard (“CFS”) transportation electrification general services to Customers or other approved entities in accordance with the Washington State Department of Ecology requirements as stipulated under RCW 70A.535.080.

GENERAL SERVICES:

At its sole discretion, the Company may provide grants, incentives or other types of funding of up to one hundred percent (100%) of the cost for transportation electrification general services or other eligible projects that reduce greenhouse gas emissions, which may include but are not limited to:

- Transportation Emission Reduction Grants
- Electric vehicle (EV) and micromobility procurement
- EV charging incentives, including Company-side and Customer-side infrastructure and point-of-sale discounts or credits
- Partnership programs with public and private vehicle fleets
- Marketing, outreach, and education services
- Customer-incurred transportation electrification costs in excess of incentives provisioned through tariffs Schedules 550-559
- Associated turn-key and make-ready projects

SOURCE OF FUNDING:

Availability of all general services offered in this Schedule is subject to the availability of funding and will be offered to support transportation electrification projects, as stipulated in the Department of Ecology CFS Guidance on Residential EV Charging Credit Revenue Requirements<sup>1</sup> and in accordance with section 70A.535.080 RCW of the CFS statute and Chapter 173-424-420(7) WAC of the CFS rule.
