On December 7, 1994, Marvin Road Water Company (Marvin Road) filed with the Commission revision to its currently effective tariff WN U-1 in Docket UW-941581. Marvin Road currently serves approximately 232 customers in Thurston County.

The revision is designated as:

6th Revision Sheet No. 21

The Commission, on January 25, 1995, entered a Complaint and Order Suspending Tariff Revision pending an investigation concerning the charges and reasonableness and justness thereof.

This tariff revision is a filing requesting the rate increase to cover maintenance and operating costs. In addition the company states it has completed it's Comprehensive Water System Plan. The revenue impact of this filing would be an additional \$17,365 per year.

On March 30, 1995, the company requested permission to withdraw the filing in Docket UW-941581. On March 30, 1995, the company filed a tariff revision at revised levels. The revised rate levels would produce approximately \$14,000 additional revenue per year. The company has requested that the filing in Docket UW-950395 be allowed to become effective by less than statutory notice and with an effective date of April 13, 1995.

An accounting investigation of the general rate increase has been completed, utilizing as a test period the twelve months ended December 31, 1993. The results of that staff investigation of the revised rate are not contrary to the public interest and appear to be fair, just, reasonable, and sufficient.

FINDINGS

- 1. Marvin Road Water Company, Inc., is a water utility company and as such is a public service company subject to the jurisdiction of the Commission.
- 2. The revision presently under consideration herein is not considered to be unreasonable.
- 3. It is not contrary to public interest that the Compliant and Order Suspending Tariff Revision in this docket be dismissed.
- 4. After careful examination of the tariff revision herein by respondent, March 30, 1995, and giving consideration to all relevant matters and for good cause shown, the Commission finds that the tariff revision should become effective April 13, 1995.

ORDER

THE COMMISSION THEREFORE ORDERS:

- 1. That the Complaint and Order Suspending Tariff Revision in this Docket, UW-941581, dated December 7, 1994, be and the same is hereby dismissed.
- 2. That the requested less than statutory notice in connection with the tariff revision filed herein by Marvin Road Water Company, Inc., Docket UW-950395, March 30, 1995, is hereby granted, and said tariff revision shall become effective April 13, 1995.
