GTE Northwest Incorporated (GTE Northwest) makes application to the Washington Utilities and Transportation Commission (Commission) for an order approving an Agreement between Mast Advertising & Publishing, Inc. and Continental Telephone Company of the Northwest, Inc. dated August 15, 1985, and an amendment to that Agreement between GTE Northwest and Associated Directory Services Inc. After the execution of the directory publishing contracts, Continental Telephone was merged into GTE Northwest. Subsequently, SBC Communications, Inc., the parent of Associated Directory Services Inc. (formerly Mast Advertising & Publishing, Inc.), sold the directory publishing contracts to GTE Directories. Accordingly, GTE Northwest and GTE Directories are affiliated interests as defined under RCW 80.16.010, as they both are wholly owned subsidiaries of GTE Corporation. In accord with the provisions of WAC 480-146-090, the following general information and specific exhibits are furnished in support thereof:

The Applicant has one subsidiary company: GTE West Coast Incorporated (GTE West Coast), 1800 41st Street, Everett, Washington, which was incorporated on May 31, 1928 in the State of California. GTE West Coast has 93,176 shares of \$25 par value, common stock outstanding, all of which are owned by GTE Northwest. Applicant has 100% voting control over GTE West Coast.
