### The Purpose of this Filing

Puget Sound Energy ("PSE") herein files updates to its electric and natural gas rates as an expedited rate filing ("ERF") consistent with the process and procedures used by the Commission in Dockets UE-130137 and UG-130138, and the parameters identified in Exhibit I to the Multiparty Settlement Stipulation and Agreement in Dockets UE-170033 and UG-170034, except where Commission Staff has requested that PSE make changes to the format of the filing. The substantive changes PSE made based on input from Commission Staff, are first, removal of only the variable power costs rather than all production related costs, and second, the use of end of period depreciation to be consistent with the reflection of plant at end of period balances. Overall, these filings represent a rate increase of \$18.9 million or 0.9% for electric customers and \$21.7 million or 2.7% for natural gas customers. Because this rate request is intended to be a limited, expedited rate filing and not a general rate proceeding as set forth in WAC 480-07-505(1), PSE has limited the rate increases requested for natural gas service. The full natural gas revenue deficiency would exceed 3%, therefore, a lower rate request is being made in this expedited rate filing.

Additionally, PSE submits revisions to its electric and natural gas Schedule 142 Revenue Decoupling Adjustment Mechanisms, specifically Delivery Revenue per Unit, Allowed Delivery Revenue per Customer, Fixed Power Cost Revenue per Unit and Allowed Fixed Power Cost Revenues. PSE makes these filings electronically via the Commission's web portal, and pursuant to WAC 480-07-140(5), paper copies are not being provided. If the Commission requests that PSE provide paper copies, PSE will provide the requested number of copies.
