Other Information: When locates were initially called in via the one call service, the locating service contractor did not notify the contractor that the high pressure gas main - which ended up being the utility line that was miss-located - would require a gas monitor to be onsite. This caused a start delay of this potholing activity which was initially scheduled to take place on 3/8/21 but due to no notice provided by locate service - which is standard procedure - this potholing activity was unable to begin until 3/10/21. Potholing for this gas main began at 9:00 AM on 3/10/21 and proceeded as a standard potholing with no issues until 9:30 AM. At 9:30 AM the PSE representative/ Gas inspector onsite raised concerns about the accuracy of locates as the line had not been located yet after hydro excavating down 6' on the locate marks. The inspector for PSE & the City of Renton (also onsite at the time) began to make phone calls to verify or gather further information on the line and the locates provided. Inspector for PSE gave JCC excavators direction to pothole towards the east from where the gas locates were painted. Line remained unfound. PSE inspector determined he would drive down to access box and hook on to tracer wire to locate the HP gas line himself. While inspector was off attempting to locate the line, JCC exposed a pipe that was 8", which was confirmed by Gas inspector to be the 8" HP line. The gas main was found 8 feet east of the locate marks provided by locate services.
