Re: Cascade Natural Gas Conservation Program Adjustment Annual Filing

Dear Mr. Johnson:

Cascade Natural Gas Corporation ("Cascade") hereby encloses for filing the following proposed tariff sheet containing a requested effective date of November 1, 2021:

Eighty-Seventh Revision Sheet No. 596 Canceling Eighty-Sixth Revision Sheet No. 596

The purpose of the conservation program adjustment (CPA) filing is to pass on changes in the amount of conservation program expenditures affecting customer rates as a result of deferral account amortizations.

The rates contain information developing the level of the per therm change necessary to amortize the outstanding deferral balances of \$7,823,143 for the twelve months ended July 31, 2021. The \$7,823,143 is comprised of \$2,610,834 for the residential program, \$978,262 for the commercial program, \$692,573 for the low-income program, \$2,120,917 is for administration costs, and \$1,420,557 is for the residual balance from last year's filing. The total amortization requested in this filing is a debit of \$7,547,600. The annual revenue change reflected in this filing is an increase of \$940,337 to customers, or an increase in annual revenue of 0.36 percent. Below is a table summarizing the proposed changes reflected in this filing:

The impact of the CPA is a revenue increase of \$940,337 or a 0.36 percent increase. The impact to an average residential customer using 56 therms per month will be an increase of \$0.21 or 0.37 percent.

The proposed change will affect all of Cascade's retail sales customers. Cascade serves approximately 197,371 residential, 26,933 commercial and 484 industrial customers in the state of Washington.
