Jammie's Environmental, Inc. requests a solid waste collection certificate of public convenience and necessity authorizing it to operate as a Specialized solid waste collection company (as a class C company) from Packaging Corporation of America located at 31831 S Hwy 12 in Walulla, WA 99363 specifically for industrial and commercial industries that we currently provide other services to. Primary commodity to be hauled: processed OCC reject waste other commodities to be hauled on occasion: hazardous waste, dangerous waste, special waste (e.g. any solid waste that requires additional processing, special handling, special packaging, special transportation and or additional disposal techniques due to its quantity, concentration, physical or chemical characteristics or biological properties, and other solid waste that is not hazardous, dangerous or special, excepting (a) Non-hazardous solid waste from residential customers, (b) Municipal solid waste and (c) biomedical or biohazardous waste. Dropbox service may be provided for Hazardous, Dangerous and/or special waste only.

The purpose of this application is to request authority to manage and transport Processed OCC reject waste from the Packaging Corporation of America located at 31831 S Hwy 12 in Walulla, WA 99363 (Walla Walla County) to Finely Butte Landfill located at 73221 Bombing Range Road in Boardman, OR 97818 (Morrow County)

Jammie's Environmental, Inc. requests non-exclusive authority to collect solid waste as described in section 3 of its application from industrial and commercial industries that we currently provide other services to. Washington generators (both industrial and commercial) benefit from competition in the market for processed waste, hazardous waste, dangerous waste and special waste collection services for reasons similar to those advanced by the Washington Utilities and Transportation Commission in the matter of STERICYCLE OF WASHINGTON, INC. v. WASHINGTON UTILITIES AND TRANSPORTATION COMMISSION and Waste Management of Washington, Inc. 190 Wn App 74 (Wash, CT, App. 2015) (relating to the collection of biomedical waste)

Jammie's Environmental, Inc. has been providing specialized cleaning services since 1999. Jammie's Environmental, Inc. offers a multitude of services to industrial and commercial industries; we do not provide services to residential customers. Jammie's Environmental, Inc. services include but are not limited to industrial cleaning services, vacuum truck and tanker services, hydroblast services, vacuum excavation services, tank cleaning services, confined space entry services, hy-rail and multiple railroad services to clients throughout the western United states. At times, our services include but are not limited to the transportation and disposal of both solid and liquid processed waste, hazardous waste, dangerous waste and/or special waste. Generally, the service of transporting and disposal of waste is incidental to the other services provided to our customers but in certain circumstances, clients will ask for support in managing their waste in conjunction with other services we currently provide. We strive to provide excellent customer service to our customers, which is in many ways how we have grown over the last two decades. Our main goal as a company is to provide our services in the safest way possible while meeting and/or exceeding the needs of our customers.

Jammie's Environmental, Inc. has worked at this facility in Walla Walla County for about ten years. We have equipment and crews working at this facility daily and are very familiar with the day-to-day operations of the facility and feel that we are very responsive to their needs. We work alongside multiple other contractors who provide services to this facility, including but not limited to refuse collection and disposal contractors who provide multiple bins throughout the facility for refuse material. We are all working together ensure that the facility runs safely and productively.

Jammie's Environmental, Inc. feels that the following conditions should justify granting our application. During March of 2021, the facility started a “new to them” process of manufacturing paper products from Old Corrugated containers (OCC). This type of operation consists of processing bales of recycled cardboard, during the process the material that cannot be recycled such as plastic, steel, tape and other non-fibrous, non-recyclable material that is a contaminant to the manufacturing process are rejected and need to be managed separately. This waste is considered processed OCC reject waste. The facility started out at 60%-80% capacity, the current refuse collection and disposal contractor provided multiple roll off bins to the facility for facility employees to load the OCC reject waste into, the current refuse collection and disposal contractor was unable to keep up with the amount of processed OCC reject waste. The facility stated they had called the

refuse collection and disposal contractor on a regular basis to request them to remedy the problem but the problem was not addressed which created a stockpile of processed OCC reject waste which was at the time equivalent to about 500 yards of material stockpiled at any given time which created a fire, safety and environmental hazard for the facility.

Given the variety of services, we already provided the facility, on or around May of 2021, the facility approached Jammie's Environmental, Inc. for suggestions and solutions to their processed OCC reject waste stockpile, which was creating a fire, safety and environmental hazard issue.

Jammie's Environmental, Inc. suggested that we provide a 5-yard wheel loader and our 80-yard belt trailers to transport the processed OCC reject waste directly to the landfill. We contacted the landfill and submitted a profile for the process OCC reject waste and the material was approved for acceptance.

On or around the last week in May of 2021 Jammie's Environmental, Inc. started managing and hauling the processed OCC reject waste in conjunction with the current refuse collection and disposal contractor, by the end of June 2021 Jammie's Environmental, Inc. had remedied the issue and we were able to manage the amount of processed OCC reject waste produced by the recycling process without facility employees loading processed OCC rejects into bins which allows the OCC department to operate safely while running at capacity. The current refuse collection and disposal contractor still provides a multitude of bins for other wastes in the OCC department.

5. Please tell us about your experience and knowledge of transportation or solid waste, including knowledge of motor carrier driver and equipment safety requirements:

Jammie's Environmental, Inc. was established in 1999, we had one air mover vacuum truck and four employees. We have always prided ourselves on customer service and have grown as a company to meet the needs of our customers. We now have over 300 pieces of rolling stock and on average of 100 employees that bring a wealth of experience. We service customers primarily in Washington and Oregon. We work at a variety of facilities from the pulp and paper industry to shipyards and Railroads (and much more).

Our primary service is cleaning which in turn produces waste. As a service to our customers, we typically manage the waste that is generated during the cleaning process and our waste profiler has worked in the industry for over 35 years. We work with multiple disposal facilities to find the best solutions to the waste that has been generated. At times we are requested to provide roll offs and/or vacuum boxes for customers to contain wastes in. We work with the FMSCA, DOT and FRA on a regular basis and we understand and follow waste transportation guidelines and are very knowledgeable of federal and state regulations. We have a full time shop and employ five full time mechanics to keep our equipment operating safely and efficiently. All of our CDL vehicles are equipped with ELD's which assist us in monitoring driver HOS and behaviors. All our employees receive extensive annual safety training, the majority of our personnel possess a TWIC (transportation worker identification credential) card.
