Dear Multi-Family Customer,

This is to notify you of a proposed rate adjustment for Multi-Family services in the City of Edmonds, WA, where Sound Disposal, Inc. operates. It has been thirteen (13) years since our last general rate increase. This notice informs you of a proposed change in the garbage collection portion of your invoice. Sound Disposal, inc. has filed a request to adjust the commercial garbage collection rates with the Washington Utilities and Transportation Commission (UTC). If the UTC approves this request, the new rates (shown below) will become effective July 1, 2022,

The Commission has the authority to set final rates that may be either lower or higher than the company's requested adjustment, depending on the results of its investigation.
