Notice of Cancellation of Your Insurance

The Washington Utilities and Transportation Commission (Commission) has received notice that your insurance will be cancelled on 12/6/2022. State law requires you to file and maintain proof of public liability and property damage insurance to maintain your permit or certificate to operate in Washington. If you do not intend to cancel your operating permit or certificate, contact your insurance agent today to submit a Form E or temporary Binder by the due date to transportation@utc.wa.gov.

What happens if you do not file proof of insurance by 12/6/2022?

If you do not file a proof of insurance certificate (Form E or a temporary binder) by 12/6/2022, the Commission will cancel your permit or certificate.

What happens if your permit or certificate is cancelled?

If the Commission cancels your permit or certificate due to lack of proof of insurance, you will have to stop all operations. To regain authority after the Commission cancels it, you must submit an application for reinstatement, pay the reinstatement fee, and provide proof of insurance (Form E or a temporary binder). You may not operate until you receive a new permit or certificate.
