Pursuant to RCW 80.28.060 and WAC 480-80-101 and WAC 480-80-105(1)(c), please find enclosed for filing the following proposed revision to the WN U-2 Tariff for natural gas service of Puget Sound Energy ("PSE"):

153rd Revision of Sheet No. 101-A Schedule 1, Tax Adjustment (Continued)

The purpose of this filing is to update the current utility tax rate within the City of Kenmore (the "City"). A copy of the approved City ordinance, Ordinance 23-0570, which increased the tax for natural gas utilities to six percent, is enclosed.

A work paper detailing the recovery of additional taxes, fees and expenses associated with the collection of the municipal utility tax, is also enclosed. With these adjustments, this filing proposes to update the current rate of 4.360 percent to 6.686 percent. The typical residential gas customer using an average of 64 therms per month would see an average monthly increase of \$2.07. Bill assistance programs are available to qualified customers who need help with their energy bills. Payment plans are also available.

PSE estimates the resulting annualized increase in gross revenues from natural gas operations and the corresponding increase in taxes due, to be \$302,185.
