YOU MUST RESPOND WITHIN 15 DAYS OF THIS NOTICE

The Washington Utilities and Transportation Commission (Commission) believes that Savanah Logistics LLC (Savanah Logistics or Company) violated Revised Code of Washington (RCW) 19.122.055(1)(a) by failing to notify the one-number locate service and causing damage to an underground gas facility.

RCW 19.122.055(1)(a) states, in part, that excavators who fail to notify a one-number locator service and cause damage to an underground gas facility are subject to a civil penalty of not more than \$10,000 for each violation.

Commission staff (Staff) conducted an investigation that included reviewing damage reports, investigation reports, the One Call Center database, and communications with the Company. The documents reviewed identified a natural gas event that involved Savanah Logistics damaging a natural gas facility while excavating without a valid locate ticket.

The Commission reviewed findings and recommendations made by Staff and hereby notifies you that it is assessing a \$1,000 penalty (Penalty Assessment) against you on the following grounds:

1. Alleged Violation:

On October 2, 2023, Savanah Logistics was excavating at 124 South Brandon St., Seattle, Washington. While excavating, Savanah Logistics workers struck and damaged an underground Puget Sound Energy (PSE) natural gas facility. The Damage Information Reporting Tool (DIRT) report submitted by PSE on November 15, 2023, indicated that Savanah Logistics was excavating without a valid request to locate underground utilities.

2. Analysis:

The alleged violation concerns RCW 19.122.055(1)(a), which states, in part, that an excavator must contact the one-number locate center before beginning excavation. On October 2, 2023, Savanah Logistics was doing demolition work when it struck a PSE natural gas facility. The Gas First Response (GFR) report from PSE states that Savanah Logistics was operating a bulldozer when it damaged a riser. The GFR further states that Savanah Logistics had caused similar damage 3 days prior because the Company did not wait for locates. On February 23, 2024, staff communicated by email with Savanah Logistics requesting further information regarding this incident. The Company replied on February 26, 2024, stating that PSE told them when they could start work. Staff reviewed copies of emails between PSE and Savanah Logistics and determined that PSE notified Savanah Logistics that a cut and cap should be done by a particular date, but that the Company should wait until they received a call from PSE's dispatch. The PSE GFR report states that the Company did not wait for the call from dispatch, and it did not call for a locate ticket. Staff emailed Savanah Logistics on March 27, 2024, asking for an explanation regarding the information from PSE and a copy of the locate ticket, but the Company did not respond to Staff's inquiry. Staff reviewed the One Call ticket center database and did not find a locate ticket for Savanah Logistics for this location.

The Commission considered the following factors in determining the appropriate penalty amount for the violation:

1. How serious or harmful the violation is to the public.

This incident could have been significantly more harmful to Savanah Logistics workers, utility technicians, nearby homeowners, and the public, and could have resulted in severe injury and/or loss of property.

2. Whether the violation is intentional.

The violation appears to be due to negligence and a lack of knowledge about Washington State's Dig Law. Over the past 12 months, there has been no record of Savanah Logistics utilizing the One Call Center for locate requests. However, the Commission mailed a warning letter to the Company regarding the additional damage incident PSE referenced in the GFR report. Savanah Logistics has been a licensed business since January 13, 2005.

3. Whether the company self-reported the violation.

Savanah Logistics did not self-report the violation. The Commission became aware of the violation when PSE filed a DIRT report.

4. The likelihood of recurrence.

The likelihood of recurrence depends on the Company's actions going forward and its willingness to notify the one-number locate service every time before beginning excavation.

5. The Company's previous violations.

On December 19, 2023, the Commission mailed an Alleged Violation of Washington Dig Law letter to Savanah Logistics. The letter included detailed information about Washington State's Underground Utility Damage Prevention Act, requirements for submitting utility locate requests before excavating, and the possibility of penalties for each violation. The Commission mailed the letter after receiving a report of damage caused by Savanah Logistics on September 30, 2023, that occurred because the Company failed to submit a request to locate underground utilities before excavating.

The Commission has considered these factors and determined that it should penalize Savanah Logistics as follows:

- \$1,000 penalty for one violation of RCW 19.122.055(1)(a) with an offer to suspend an \$800 portion of the penalty for one year, and then waive it, subject to the conditions that:
 - Company supervisors and field crew responsible for excavation complete Dig Safe Training provided through the National Utility Contractors Association (NUCA) within 90 days of this Penalty Assessment;
 - 2) The Company must submit documentation of that attendance to the Commission; and
 - 3) The Company must not commit any further violations of RCW 19.122 within 12 months of the date of this Penalty Assessment.

These facts, if proven at a hearing and not rebutted or explained, are sufficient to support the Penalty Assessment.

Your penalty is due and payable now. If you believe the violation did not occur, you may deny committing the violation and contest the penalty through evidence presented at a hearing or in writing. Or, if there is a reason for the violation that you believe should excuse you from the penalty, you may ask for mitigation (reduction) of the penalty through evidence presented at a hearing or in writing. The Commission will grant a request for a hearing only if material issues of law or fact require consideration of evidence and resolution in a hearing. Any request to contest the violation or for mitigation of the penalty must include a written statement of the reasons supporting that request. Failure to provide such a statement will result in denial of the request. *See* RCW 81.04.405.

If you properly present your request for a hearing and the Commission grants that request, the Commission will review the evidence supporting your dispute of the violation or application for mitigation in a Brief Adjudicative Proceeding before an administrative law judge. The administrative law judge will consider the evidence and will notify you of their decision.

You must act within 15 days after receiving this Penalty Assessment to do one of the following:

- Pay the \$1,000 penalty amount due; or
- Pay \$200 and notify the Commission that you accept the offer to suspend an \$800 portion of the penalty amount subject to the following conditions:
 - Savanah Logistics management and field crew responsible for excavation must complete NUCA Dig Safe Training (<u>https://utc-9183.quickbase.com/db/bpkt6vndh</u>) within 90 days of service of this Penalty Assessment; and
 - The Company must submit documentation of that attendance to the Commission; and
 - Savanah Logistics must not incur any additional violations of RCW 19.122 within 12 months of the date of this Penalty Assessment; or

- Request a hearing to contest the occurrence of the violation; or
- Request mitigation to reduce the amount of the penalty.

 - The Company must not commit any further violations of RCW 19.122 within twelve (12) months of the date of this Notice.
- [] 3. Contest the violation. I believe that the alleged violation did not occur for the reasons I describe below (if you do not include reasons supporting your contest here, your request will be denied):
 - [] a) I ask for a hearing to present evidence on the information I provide above to an administrative law judge for a decision.
 - OR [] b) I ask for a Commission decision based solely on the information I provide above.
- [] 4. **Request mitigation.** I admit the violation, but I believe that the penalty should be reduced for the reasons set out below (**if you do not include reasons supporting your application here, your request will be denied**):
 - [] a) I ask for a hearing to present evidence on the information I provide above to an administrative law judge for a decision.

OR [] b) I ask for a Commission decision based solely on the information I provide above.
