1 Auto Transportation Company Certificate No. C-1079, standing in the name of Edward Masters, d/b/a Orcas Island Shuttle, was issued in accordance with RCW 81.68 and authorizes the following:

Passenger Service on Orcas Island between the Orcas Ferry Landing (Orcas) and Lieberhaven Resort (Olga) and all intermediate points via the following routes: Orcas Road, Pinned Road, Beth Ridge Road, Crow Valley Road, Main Street, North Beach Road, Mt. Baker Road, Olga Road, Rosario Road, Pt. Lawrence Road, and Destruction Pass Road

2 The Commission is in receipt of a letter dated May 20, 2004, from Edward Masters requesting correction to road names in Certificate No. C-1079. The certificate incorrectly identifies "Pinned Road" as the connecting road between Orcas Road and Beth Ridge Road. The correct road name should be "Deer Harbor Road." The certificate also incorrectly names "Destruction Pass Road." The correct road name should be "Obstruction Pass Road."

3 The Commission believes that this request will not be adverse to the public interest and that Auto Transportation Company Certificate No. C-1079, standing in the name of Edward Masters, d/b/a Orcas Island Shuttle, should be revised and reissued accordingly.

**ORDER**

4 IT IS ORDERED That Auto Transportation Company Certificate No. C-1079, standing in the name of Edward Masters, d/b/a Orcas Island Shuttle, be revised and reissued as set forth in the attached Appendix A.

- 5 The Commission further orders that the tariff and time schedule filed in connection with this application will become effective at 12:01 a.m. on the day following the service date of this order.
