Dear Mr. Ward,

Enclosed is the fourth quarter 2009 report.

We had not originally been deducting the amount used to pay the excise tax for the money received. We decided to transfer these funds out of the account over two quarters to maintain a positive balance within the bank account. We originally left some of the water system operating funds within this account to maintain a positive balance when payment was made to the loan. We have now made arrangements with the bank to hold the account open even if the balance is zero. Therefore those operating funds are also being transferred out of this account. At all times we have maintained an accurate accounting of the loan funds and a positive balance within the account.

Looking at the previous quarterly reports, I noticed the amount reported as the quarterly interest was incorrect. I have revised these reports and included copies to reflect the corrected loan balance.
