I just received a courtesy phone call from Kathryn McPherson informing me I should direct the following emailed-request (which I had sent to Kathryn earlier this morning) directly to you.

Respectfully, I hereby request an emergency reschedule of the Special Proceeding "Matter of Determining the Proper Carrier Classification of and Complaint for Penalties against Cascade Recycling, Inc." Docket TG-210102.

Please understand this past Monday (8/23/21) afternoon I underwent what was to be a fairly routine eye surgery for cataract removal/lense replacement.

On Tuesday (8/24/21) afternoon, the post-operative bandages were removed and I could not see out of my right eye: The ophthalmologist-surgeon (Dr. Roger Anderson) determined the lazer had cut excessively into the retina & destroyed the lense.

Dr. Anderson immediately referred to a vitreoretinal specialist (Dr. Himanshu Banda) for further testing. Yesterday afternoon Dr. Banda scheduled an emergency repair surgery for his next available time on 8/31/21.

In seeking a suitable upcoming date to reschedule, it is important to inform you I currently have two succesive right leg surgeries scheduled on 9/20/21 & 9/27/21 with Dr. Jeffrey Freidrich @ Harborview Medical Center.

Kathryn had suggested I include several suitable dates for rescheduling. In checking with my attorney, Mike Johns, he requested any date after October 4, 2021, which certainly should allow me plenty time to heal.
