RE: *Washington Utilities and Transportation Commission v. Mr. Muscles Moving Company LLC*
Commission Staff's Response to Request for Payment Arrangement
Docket TV-220417

Dear Ms. Maxwell:

On June 28, 2022, the Washington Utilities and Transportation Commission (Commission) issued a Notice of Intent to Cancel; Notice of Hearing Setting Time for Oral Statements; Complaint for Penalties; and Notice of Prehearing Conference in Docket TV-220417.

On July 29, 2022, the Commission entered Order 01, Approving Safety Management Plan; Maintaining Safety Rating; Extending Provisional Period; and Imposing and Suspending Penalties (Order 01). Order 01 assessed an \$8,000 penalty against Mr. Muscles Moving Company LLC (Mr. Muscles Moving or Company) and suspended a \$6,000 portion of the penalty for a period of two years, subject to the following conditions:

- (1) Alex Conner, owner of Mr. Muscles Moving, must attend Commission-provided household goods training on August 4, 2022,
- (2) The Company must maintain a conditional safety rating,
- (3) Commission staff (Staff) must conduct a follow-up investigation of Mr. Muscles Moving at least six months from the effective date of Order 01,
- (4) The Company may not incur any repeat critical violations of WAC Chapter 480-15 upon re-inspection, and
- (5) Mr. Muscles Moving must pay the \$2,000 non-suspended penalty within 10 days of Order 01 and may work with Staff to establish mutually agreeable payment arrangements.

On September 2, 2022, Mr. Muscles Moving contacted Staff and both parties came to a mutual agreement on a proposed payment plan, as follows:

Despite Mr. Muscles Moving contacting Staff after the deadline specified in Order 01, Staff recommends the Commission grant the Company's request for payment arrangements. Mr. Muscles Moving is aware that if it fails to pay any installment by the due date, the entire remaining balance, including the suspended penalty, will immediately become due and payable without further Commission order.
