**Public:** The EV charging solutions provided by PSE's expanded Public charging program will help meet the charging needs of EV drivers living, working, and visiting businesses in our community, while also helping the greater community to meet our own clean future goals. The program supports curbside charging installations, makes space for customers interested in multi-purpose charging stations (e.g. fleet, public and workplace), and supports diverse charging installation siting (in business districts, residential neighborhoods, parks and community centers).

**Workplace:** The Workplace charging solutions offered by PSE aim to help us meet our organizational and employee charging needs though installation and maintenance incentives, provide equitable access to EV charging for employees without access to dedicated home charging options and support regional carbon reduction.
