## **Recommendation**

Issue a Complaint and Order Suspending Effective Date and set the Petition for hearing as soon as possible.

## **Background**

On January 8, 2024, Qwest Corporation d/b/a CenturyLink QC, et al. (LUMEN or Company) filed a Competitive Classification Petition (Petition) requesting an order from the Washington Utilities and Transportation Commission (Commission) classifying the five CenturyLink incumbent local exchange carriers (ILECs)<sup>1</sup> as *competitively classified companies* pursuant to RCW 80.36.320.

LUMEN proposes an effective date of June 1, 2024. WAC 480-121-065 requires the Company to provide notice to each affected customer at least 30 days before the requested effective date. The Company has not yet notified its customers but is working with the Commission's public involvement coordination team on how to best accomplish this outstanding requirement.

## **Discussion**

Commission staff (Staff) has initially reviewed the Company's Petition and determined that it should be suspended in order to investigate the evidence either provided or omitted and to allow all other parties including the Public Counsel Unit of the Attorney General's Office to participate in the proceeding. Because the deadline for action by the Commission is six months from the date of filing pursuant to RCW 80.36.310(2), a prehearing conference should be held as soon as possible in order to complete the proceeding<sup>2</sup> by July 8, 2024. Additionally, Staff will request that the discovery rule be invoked and that a protective order also be established and issued in this case due to the highly sensitive nature of the data and potential proprietary information concerns associated with the CenturyLink ILECs' and their competitors' information.
