I am copying all parties on the Service List for U-180680 with this email.

I need to bring to your attention a timing matter regarding my Petition for Administrative Review of an Interlocutory Order Denying my intervention in Docket No. U-180680. The PHC Order 03 in this proceeding was made available late on Wednesday Nov 21. I filed my Petition for Administrative Review as soon as I could following the posting of that Order. As you can see from the email below, I filed my Petition at 8:52 AM on Nov 22. Less than 12 hours after Order 03 was posted. I learn today that because of the 4 day holiday, responses to my Petition are not due until December 6. You three Commissioners will then need to decide if you will grant the Relief I request (i.e. allow me to be a party in U-180680).

My concern is that Order 03 also set December 18 as the date for the Initial Settlement Conference.

If you grant the Relief I request, it would be desirable for me to have time to conduct a little discovery and have responses before that Initial Settlement Conference on December 18.

Please take into account these timing matters as you set your schedule for dealing with my Petition for Administrative Review of an Interlocutory Order Denying my Petition to intervene in U-180680.
