- 1. For all the reasons set forth in Verizon Northwest Inc.'s Response to Complainants' Motion for Summary Disposition, which arguments are incorporated herein, Verizon supports Staff's Motion For Summary Disposition. Verizon files this Response only to identify two issues touched on by Staff's Motion which need not, under the facts of this case, be resolved.
- 2. First, Staff suggests in passing that the current system of access charges is not required by RCW 80.36.160. Staff's Motion For Summary Determination [Corrected], at 4, fn. 4. Verizon respectfully submits that the statutory basis for the current access charge system is a complicated question, raising matters that go far beyond the issues presented in this proceeding. Moreover, addressing such an issue is not necessary to determine whether access charges should be assessed for LocalDial's service. Verizon respectfully requests that the Commission refrain from addressing this question, given the limited brief presented on this complex question.

3. Second, Staff's memorandum presents some discussion of the jurisdictional division between interstate and intrastate regulation of telecommunications. Staff's Motion for Summary Determination [Corrected] at ¶¶ 21-22, ¶¶ 38-39. Again, the complicated question whether *true* Voice Over Internet Protocol services would be subject to intrastate regulation is simply not raised by LocalDial's actual service. As Staff correctly notes, LocalDial's service is nothing more than "IP-in-the-middle VoIP," Staff's Motion for Summary determination [Corrected], at 31, ¶54, and is thus a functional equivalent to traditional inter-exchange service provided by toll carriers. *Id*, ¶53. The more complicated questions of the appropriate treatment of true VoIP, involving computer-to-computer or computer-to-phone services, *see* Staff's Motion for Summary Determination [Corrected] at 26-27, ¶¶47-48, are simply not presented on the facts of this case. Verizon respectfully urges the Commission to not venture into an advisory opinion in this Complaint case.
