TO INTERESTED PERSONS:

On March 14, 2001, the Commission approved the repeal of the customer notice rules from Chapter 480-80 Commission General – Tariffs, and the adoption of customer notice rules in individual industry chapters – WAC 480-90 Natural Gas Operations, 480-100 Electric Operation and 480-120 Telecommunications Operations. This action followed the last request for comments and the stakeholder workshop held on February 28, 2001.

Staff has prepared another draft of proposed customer notice rules based on discussions at the last workshop. The Commission requests your written comments. In addition to the opportunity to submit written comments, you are invited to attend a stakeholder workshop. At this workshop, Staff will discuss the draft rules and provide an opportunity for further comment.

The draft customer notice rules are available for inspection on the Commission's web site at <www.wutc.wa.gov/991301>. The Commission will send a paper copy of the draft customer notice rules, if requested. See information below about contacting the Commission.

The draft customer notice rules include the following:

480-090-193 - Customer notice requirements (natural gas)

480-100-193 - Customer notice requirements (electric)

480-120-043 - Customer notice requirements (non-competitive telecommunications)

Staff has prepared two alternatives for each rule. As discussed at the February workshop each alternative includes provision for customer notice for formal hearings formerly included in the draft rule 480-080-125 - Formal hearing customer notice.

<u>Alternative 1</u>: This approach includes general guidance on when notice is to be provided prior to Commission action. It also includes a provision that, if the Commission does not have sufficient information from customers to determine the fairness of a filing, the Commission may suspend the tariff revision to allow additional time for customer notice and comment.

<u>Alternative 2</u>: This alternative requires that, for specific types of tariff revisions, each customer receive a minimum of 21 days prior notice.

In addition, the following rules are also available for review and comment:

480-120-X15 - Customer notice requirements - competitive telecommunications companies or services

480-121-X04 - Customer notice requirements - petition for competitive classification of a service.
